Discussion of creation of Step Up league in April, to transition beginner clinic participants to summer league play. Marty suggested to have new Step Up League right away so they can join Tri and Mixed for the summer with Registration beginning March 28<sup>th</sup> through April 18<sup>th</sup>.

Jonathan said we added a "button" on the website last year for new players and have received over 110 responses of people interested during Covid.

## **President's Update:**

Strategic Plan – Short term and Long term goals/plans need to be better defined. Troy & Randy to chair a new ad hoc Strategic Plan committee to further explore possibilities & report back to the Board. Possibilities may include working with BREC to upgrade existing facilities, especially lighting, but also possibility of GBRCTA creating own Foundation, hosting own fundraising tournament and managing its own tennis facility (cited to recent Lafayette & Shreveport CTA initiatives).
